

## **REGISTRATION GUIDELINES**

### **REGISTRATION**

There will be a non-refundable registration fee of \$25/year per family due at the time of enrollment.

### **MEDICAL/LIABILITY WAIVER**

You must sign our medical/liability waiver before your child can participate in tumbling or cheer classes.

### **TUITION**

All class fees are due on or before the first class of the month. If payment is not received before the second class of the month, students will be prohibited from participating in the class until fees are paid in full. A \$10.00 late fee may be applied. Refunds will not be available after the first class of the month. There will be a \$20.00 fee for returned checks. We will give discounts to families who have two or more students participating in classes.

### **MAKE-UP CLASSES**

Tuition will not be prorated or refunded for missed classes. Tuition does not vary due to holidays or the number of weeks in a month. If a student misses a class for any reason we will do our best to put him/her in a make up class, but this cannot be guaranteed. If school is out for any reason, tumbling classes will also be canceled. Holidays do not count as missed classes and will NOT be made up. If you decide to drop your child from a class please give us two weeks notice.

### **ATTENDANCE/WAITING LIST**

We normally have a large waiting list for our tumbling classes. For that reason, please let us know if you are going to be absent. If we do not hear from you after two missed classes we will fill your spot with the next person on the waiting list.

### **DRESS CODE**

Athletic attire (shorts, tee-shirts, leotards) is to be worn to class. Please do not have any zippers, buckles or snaps on clothing. Students may tumble in shoes or barefooted. If they choose to tumble in tennis shoes, the shoes should be clean. All students are to wear their hair tied back off their shoulders and out of their faces. Students should not bring jewelry, gum, candy or food to class.

### **STUDENTS ARRIVING AND DEPARTING**

**PLEASE BE ON TIME!** Classes begin promptly!

There will not be anyone at the gym to watch your children before and after class times. Please do not drop students off more than 10 minutes before his/her scheduled time. Students should be picked up promptly after class. We cannot be responsible for students before or after class. Please drop off the child enrolled in classes ONLY~ Friends or siblings are not to be left at the gym without an adult.

**NOBODY** is ALLOWED to go up and down the halls of the school!
